

Data Analysis

The annual <u>Geneva Engage Awards</u> aim to acknowledge the efforts of actors in International Geneva in social media, outreach and engagement. It assesses the interplay between International Geneva, where many policies are negotiated, and global stakeholders since 2016. The project is run by the <u>Geneva Internet Platform</u> (GIP) and supported by the <u>Republic and Canton of Geneva</u> and <u>Diplo</u>.

The Geneva Engage Awards are given to:

- · International Organisations (IOs)
- · Non-governmental and non-profit organisations (NGOs)
- · Permanent Representations (PRs)

To be a nominee for the awards, actors in these three categories need to be based in the Canton of Geneva.¹

Since 2020, the Geneva Engage Awards have recognised efforts in developing effective and innovative approaches to conducting remote and hybrid meetings. With the unfolding of the COVID-19 pandemic and the shift to online conferencing, online and hybrid modes of participation have become even more central to International Geneva in its activities.

In 2022, the 7th edition of the Geneva Engage awards introduced **Geneva's Digital Footprint survey**, which determines the web relevance of Geneva-based actors. It was generated via a pilot-beta platform developed by Diplo's <u>Al and Data</u> team. Its purpose is to visualise and analyse the Google search volumes Geneva-based actors for various policy, governance, and diplomatic topics, from more than 50 cities worldwide.

Accessibility awards

The 8th Geneva Engage Awards introduced a new Accessibility Award to encourage and recognise the website accessibility efforts of Geneva actors. A dedicated accessibility session during the awards ceremony recognised that accessibility goes beyond websites and includes language, alt text, and many unseen elements. This requires the will to implement, reach out to, and *engage* everyone.

To measure an organisation's accessibility score, a tool called <u>Lighthouse</u> was used to assess desktop and website accessibility performance. The program bases its audit on numerous indicators, such as accessible element names, sufficient contrast ratio of background and foreground colours, alt text in image elements, and discernible names of the links, to name a few. The Geneva-based organisations were then ranked according to accessibility indices for desktop and mobile displays.








What does International Geneva tweet about?

For the 8th Geneva Engage Awards, Diplo's AI and Data team enhanced the analysis of Geneva's online outreach by identifying the most tweeted terms by Geneva-based organisations in the past year. Based on the tweet analysis, they identified the key 'influencers' in Geneva in 2022.

Methodology

The analysis of social media outreach for the 8h Geneva Engage Awards was conducted from 1 January to 31 December 2022.

We have considered statistics on Facebook, Instagram, and Twitter accounts as data sources for our analysis. Twitter data was obtained through the Twitter API, whereas statistics from Facebook and Instagram were kindly provided by Matthias Lüfkens of DigiTips. The analysis was conducted for actors with active Twitter accounts from 1 January 2022 onwards. To participate in the analysis, it was not mandatory for the organisation to have Facebook and Instagram accounts. However, additional points were given to organisations with Facebook and/or Instagram presence.

The accounts were measured along the following indicators:

Twitter

- Number of followers and following
- · Number of tweets
- · Growth and relative growth of followers compared to the previous year
- · Growth and relative growth in number of tweets compared to the previous year
- Engagement rate based on average likes and tweets
- · Interaction between Geneva-based actors based on retweets and mentions

Facebook

- Number of followers
- · Growth and relative growth of followers compared to the previous year
- · Total number of posts and the average number of posts daily
- Total interaction rates, i.e. total of all likes, shares, comments, and reactions
- · Page likes and reactions
- Page growth and relative page growth.

Instagram

- · Total interaction rates, i.e. a total of all likes, shares, comments, and reactions
- · Total number of posts and the average number of daily posts
- Number of followers
- · Growth and relative growth of followers compared to the previous year



The statistical analysis

We first determined outliers in each category (both in high and low ranges) by applying the interquartile range rule:

Where IQR is interquartile range, Q1 and Q3 are first and third quartile, and O_{\perp} and O_{\perp} are high and low outliers, respectively.

We used the capping of values to compensate for differences in the raw values (i.e. everything above value X has the maximum number of points). We have used outliers as a capping point in our case. After this step, we used the following formula to calculate the ranking in the main array, which assigns points for each indicator for each organisation:

This way, we have rescaled the remaining values to a predetermined 25-point scale. The final result is the sum of points from each category.

The Geneva Digital Footprint methodology

Google ranking was used to estimate the relevance of Geneva actors' online resources (e.g. websites) for countries and communities worldwide. The team examined the Google search results of 288 Geneva-based actors from various cities, searching for one of 344 topics, ranging from trade and healthcare to humanitarian aid. The results had more than 50 cities worldwide. For each actor, points were assigned whenever the actor's domain appeared in Google's top ten search results. Points on a scale from zero to ten were assigned to each actor depending on the actor's domain position. The sum of all points awarded for every city and topic represents the final metric for actor ranking - the total number of points.

Winners of the 8th Geneva Engage Awards

Online participation

WMO received the Geneva Engage Award for excellence in online meetings. The award recognises WMO's use of online meetings to engage communities worldwide in critical discussions about weather, water and climate issues. Online meetings allowed more countries and communities worldwide to get involved in addressing the critical issues of climate change and extreme weather.

The World Meteorological Organization ranked highly in all key components of online meetings:

- Technology (use of a wide range of platforms, apps, and other tools);
- · Security (preserving the integrity of meetings and data);
- · Diplomacy (adjusting meeting procedures for hybrid and online meetings);
- · Inclusion (involving all concerned actors via multilingual facility and accessibility);
- · Behavioural dynamics (facilitating social and emotional dynamics).

The 2023 Award for effective and innovative online meetings recognises, in particular, WMO's successes in streamlining its use of online and hybrid meetings through adapting procedures, training staff, and raising awareness in WMO constituencies. In addition, WMO has been developing the concept of regional meeting hubs, which will strengthen the participation of stakeholders worldwide.

The Award recognises the WMO's commitment to policy inclusion and its efforts to use technology to foster global collaboration and discussion on critical weather, water and climate issues.

Accessibility

The first-ever Accessibility award was given to the International AIDS Society (IAS) for its excellent implementation of website accessibility!

Social media engagement

T. The <u>World Economic Forum</u> (WEF) receives the honourable mention for social media engagement, outperforming other entities in Geneva by a very high margin. Congratulations to WEF for its outstanding effort and the sheer quantity and quality of its social media activity!


About this report
